- Entire policy for General Liability Insurance for Aerie & Auxiliary with the Grand Aerie Fraternal Order of Eagles listed as ADDITIONALLY insured. The Auxiliary may hold their own policy or may be NAMED insured in Aerie policy
- Bond or Employee Dishonesty coverage within your policy

- Liquor Liability Insurance
- Signed 2017 Affiliation Agreement (Next one due 2022)
- Annual Auditor and Treasurer Reports
- 990 filed for Fraternal Year ending on May 31, 2018. The IRS 990 Form is due October 15th. If an extension was filed the deadline is April 15, 2019. The extension must be submitted to the Grand Aerie Compliance Department
- Per Capita Tax, Membership Fees, Dues Reminders and Supplies Invoices paid in full to date
